

# Vysoká škola výtvarných umení v Bratislave

## Criteria

### **of the Academy of Fine Arts in Bratislava to evaluate the fulfillment of the conditions for obtaining the art-pedagogical title "professor" in the field of Fine Art at the inaugural event.**

The Art Council of the Academy of Fine Arts and Design in Bratislava approved on 17 August 2022 in accordance with § 12 par. 1 letter e) Act 131/2002 Coll. on universities and on amendments to certain laws as amended (hereinafter referred to as "the law") and § 1 et seq. Decrees of the Ministry of Education and Culture of the Slovak Republic no. 246/2019 Coll. on the procedure for obtaining the scientific-pedagogical and art-pedagogical titles docent and professor as amended (hereinafter referred to as the "decree") these Criteria of the Academy of Fine Arts in Bratislava for evaluating the fulfillment of the conditions for obtaining the art-pedagogical title "professor" in the field of the inaugural procedure Fine Art .

## Article 1

### **Pedagogical practice**

#### 1. Content of the applicants' teaching experience:

- a) the applicant must demonstrate comprehensive and continuous pedagogical work in accordance with § 75 and § 76 of the Act,
- b) the content of pedagogical practice is leading a studio, a preparatory course or teaching professional subjects in the field of study Art, with a focus on the artistic activity of Fine Art; leading a studio, preparatory course or teaching professional subjects at another university can also be recognized as pedagogical practice,
- c) the applicant provides a list of all pedagogical activities.

#### 2. Scope of teaching experience of applicants:

It is required to carry out teaching activities for a period of at least three years after obtaining the title of docent in subjects focused on Fine Art, in which the applicant is to be awarded the title of professor. Only the time during which the applicant was employed by the university, for at least 50% of the established weekly working time (including abroad), led a professional subject, lectures, seminars or exercises and supervised doctoral students, is taken into account for the performance of pedagogical activities. A confirmation of the length of teaching experience from the home university is required.

3. The applicant must prove the successful training of at least one doctoral student in the given or related field of study and the training of at least one doctoral student after passing the dissertation examination in the given field of study.

4. The applicant must prove the publication of at least one university textbook or two scripts or two teaching texts. A university textbook or script can be replaced by the artistic-pedagogical guidance of an international creative workshop or art symposium or international conference.

## **Article 2**

### **Professional practice**

The applicant must demonstrate professional experience of at least ten years.

## **Article 3**

### **Documentation of artistic creation**

1. The results, outputs of the applicant's artistic work are considered to be decisive, and the status, current at the date of the applicant's application for inauguration, is evaluated in particular. The results and outputs of the applicant's artistic work should demonstrate that the applicant has influenced the development of the relevant field of the inaugural procedure.

2. In addition to measurable indicators of creative, pedagogical activity and responses, the level of the inaugural's portfolio as well as its compliance/non-compliance with the artistic-research orientation of the school are expertly assessed.

3. Artistic work is primarily documented:

a) documentation about a work of art or documentation of a set of realized works of art in the form of a so-called portfolio,

b) curriculum vitae and a detailed list of professional activities,

c) a filled-in quantification table indicating the quantification criteria for the Department of Inaugural Fine Art and which forms an appendix to these Criteria,

d) documenting the Quantification Table for the appointment of a professor,

e) by documenting responses to a work of art or an artistic performance, which would prove that the inaugurate is recognized as an artistic personality in international artistic circles,

f) by submitting monographs, catalogs and responses to artistic activity.

## **Article 4**

### **The documents that the applicant for the appointment as a professor must attach to the application**

To the application for appointment as a professor, the applicant shall attach:

a) professional curriculum vitae according to the model listed in the annex to the decree,

- b) a certified copy of a certificate of a second-level university education in the field of study Art with a focus on the artistic activity of Visual Arts, Design, Architectural Creation or Restoration or a corresponding field at another university,
- c) ) a certified copy of the decree by which the applicant was awarded the title of associate professor, or a decision on the recognition of professional qualifications for the performance of the position of associate professor according to a special regulation (Act No. 422/2015 Coll. amendments to some laws as amended),
- d) an overview of pedagogical activity at the university and an overview of the results achieved in this activity (§ 75 paragraph 3 of the Act),
- e) a list of original works of art, published scientific works and professional works, textbooks, teaching texts, an overview of solved research tasks, implemented technical projects or artistic projects, patents and copyright certificates, inventions and technical works, an overview of provable citations and responses to artistic creation, artistic works, scientific works or professional works, an overview of lectures and lecture stays at home and abroad,
- f) the most important artistic works, scientific works or professional works, textbooks, teaching texts, documents about works of art or artistic performances,
- g) written references to the results of the inauguration from foreign experts from at least three different countries outside the Slovak Republic.

## **Article 5**

### **Final provision**

The criteria for the appointment as a professor in the field of inaugural Fine Art were discussed and approved at the Art Council of AFAD on August 17, 2022, and will take effect on this date.

#### A. CREATIVE ACTIVITY

1. Creation and publication of a work or design<sup>1</sup> or artistic performance<sup>2</sup> of international importance<sup>3</sup>. International importance<sup>4</sup> is evidenced by reviews and awards or the international reputation of the institution/event<sup>5</sup>.
2. Creation and publication of a work or design or artistic performance of national significance. National significance is evidenced by acclaim and awards or the national reputation of the institution/event.
3. Creation and publication of a work or design or artistic performance of regional importance. Regional significance is evidenced by reviews and awards or the regional reputation of the institution/event.
4. Participation<sup>6</sup> in international symposia, workshops or conferences, the focus of which relates to the applicant's artistic practice.
5. Participation in national symposia, workshops or conferences, the focus of which is related to the artistic practice of the applicant.
6. Publishing activity in the form of author's texts for a work or artistic performance (e.g. accompanying reports and documentation, etc.), manifestos and declarations, published articles and

<sup>1</sup> A design is understood as a project that is evaluated in the framework of a publicly announced architectural, artistic or design competition and that has won one of the possible prizes or recognitions or other awards. An alternative to a publicly announced competition is a competition based on direct addressing of participants by the competition sponsor.

<sup>2</sup> The work is understood mainly for the field of architecture, design, visual art. Artistic performance is primarily tied to restoration.

<sup>3</sup> International importance is tied to output with international acclaim or awards. The given output could also be published on the territory of Slovakia, but it must have an international response. For restoration, it will also be evaluated whether the restored work is an internationally recognized art-historical work. The same applies to the reconstruction of important architectural works.

<sup>4</sup> Reactions include a monograph, a catalog, a professional reflection on a work, a review, and various types of awards. Feedback does not have to be tied to the time of the creation of the work, but can be collected gradually in subsequent years as well.

<sup>5</sup> The reference to the reputation of the institution or event is based on the record of artistic activity of CREUČ, or another verifiable database of registration of artistic performances, where lists of renowned institutions and events are defined.

<sup>6</sup> Participation mainly means conception, creative leadership and original author's contribution.

studies that name the state and development of a given type of art. The alternative is editorial activity, patents and industrial designs<sup>7</sup> of international importance.

7. Publishing activity in the form of author's texts for a work or artistic performance (e.g. accompanying reports and documentation, etc.), manifestos and declarations, published articles and studies that name the state and development of a given type of art. The alternative is editorial activity, patents and industrial designs<sup>8</sup> of national importance.

8. Curatorial and conceptual work on the preparation and implementation of an exhibition, exposition, festival, or other cultural activity that relates to the artistic practice of the applicant of international importance.

9. Curatorial and conceptual work on the preparation and realization of an exhibition, exposition, festival, or other cultural activity that relates to the artistic practice of the candidate of national significance.

10. Artistic and research projects of international importance (e.g. artistic research, interdisciplinary projects, new methods of artistic practice, etc.) with publicly presented results (work, performance, exhibition, publication, etc.) or supported by grants from public or private sources.

11. Artistic and research projects of national importance (e.g. artistic research, interdisciplinary projects, new methods of artistic practice, etc.) with publicly presented results (work, performance, exhibition, publication, etc.) or supported by grants from public or private sources.

## **B. PEDAGOGICAL AND OTHER CREATIVE ACTIVITY**

12. Requested lectures at foreign universities, professional institutions, galleries, etc.

13. Requested lectures at domestic universities, professional institutions, galleries, etc.

Completion for the habilitation: **at least 60 outputs, while at least one third of these outputs should be in the first category (A Creative activity)**. For the habilitation, the center of gravity of outputs is assumed to be in the national or international context.
